INTERIM DIVIDEND NO. 152

As authorized by the Regular Shareholders Meeting held April 19th of this year (the "Meeting"), the Board resolved to distribute the following sums as interim dividend No. 152:

- a) \$5.60 (five pesos and sixty cents) per Series A share; and
- b) \$6.16 (six pesos and sixteen cents) per Series B share.

This dividend will be paid on account of income from the 2006 fiscal year and will be available to shareholders beginning July 26, 2006. The Shareholders Registry will close on July 20, 2006 for payment of this dividend.
